## ORDERS

Dated 02.08.2018 - This case was taken up today. The appellant Sri Binayak Rath was not present and referred P.I.O. E.E.-I/EE-II/AEE (Elect.)Tax (H.Q.)/License/Parking/Land Section/Market Section/Advance Section/Bill Section/Pension Section/CMMO/All Kalyan Mandap/Deputy commissioner (Welfare)/G.store/Gen.Estt./Audit Section/Account Section/Corporation Assettes Sect./ZDC (SE)/SW/North/Sr.Mpl.Planner, BMC were present.

Gone through the case record. It is observed that the appellant had applied to the P.I.O, BMC in form 'A' on 07.05.2018 seeking information regarding non-production of paid vouchers/Registers to Audit for examination.
