- 1. The offer must be accompanied by required EMD, copy of PAN Card without which the bid shall be liable for rejection.
- 2. The bid price shall be treated inclusive of all cost, taxes, loading, unloading, transportation etc.
- 3. The bidders have to deposit an Amount of Rs. 2 Lakhs (Rupees two lakhs) only, towards EMD with A/c pay demand draft, Banker's Cheque in favour of Municipal Commissioner, BMC payable at Bhubaneswar. The offer can be made stating the price for item wise.
- 4. The successful tenderer has to deposit the full offered (adjusting the EMD) amount within three days of acceptance of the offer letter.
