Introduction:

Bhubaneswar Municipal Corporation (BMC) in its drive for taking proper care of street cows and bulls intends for an "Expression of Interest (EOI) for empanelment of Goushala with an established infrastructure for providing shelter and care to cows and bulls in Bhubaneswar". The empanelled Goushalas shall be handed over the stray cows and bulls from BMC jurisdiction for taking care at a fixed cost per month per cow/bull to be provided by BMC.

Scope of Work:

- The Goushala will be responsible for taking overall care of the Cows and Bulls handed over to them by BMC. It shall include keeping arrangement, feeding stock, medical aids and other services essential for well-being of the cows and bulls.
- The Goushala shall be responsible for providing medical assistance from a veterinary doctor as and when required.
- The Goushala shall ensure that these stray cattle are not left free to roam outside its jurisdiction.
- The Goushala shall be responsible for proper safety of the cows and bulls and prevent any kind of torture/unlawful/cruelty act against them.
- The Goushala shall be responsible to provide them clean environment in order to prevent them from diseases.
- The owner of the Goushala shall be solely responsible for all activities undertaken in the Goushala.
- The Goushala shall be responsible if any cow or bull is lost from the Goushala.

Documents to be submitted for empanelment:

- PAN/Aadhar card/Voter id of owner of the Goushala.
- Address of the Goushala.
- No. of years of operation of the Goushala
- Area of the Goushala
- Capacity of the Goushalas
- Self-declaration undertaking on a plain paper stating that there has been no case filed against the Goushala or its owner for misconduct/torture/cruelty against any animal.

Submission of the EOI proposal

The interested applicants shall submit the EOI proposal by way of hand delivery/speed post/ Registered post/ Courier on or before the last date and

time of submission of proposal mentioned above. The proposal shall not be sent through email/ fax/ hand delivery/ any other mode than mentioned above. BMC shall not be responsible for delay in receipt of the proposal sent by post or courier. The proposal shall be sealed in an outer cover clearly superscribed the subject matter as below:
